TERMS

The client agrees to the following:

- ★ The session will take place within 30 miles of downtown Columbus, Ohio and will last 1-2 hours.
- ★ It is the client's sole responsibility to contact Kelly Heasley Photography, LLC to schedule his/her session. The client will NOT be contacted by Kelly Heasley Photography, LLC to remind the client to schedule his/her session. The client will bear in mind that he/she may need to contact Kelly Heasley Photography, LLC several weeks in advance to secure a desired session date. The client will also bear in mind that it may take up to 2 weeks after the session for images to be returned to the client.
- ★ If the client fails to schedule a session during 2010, the non-refundable retainer will be forfeited.
- ★ After the session, the client will receive a disc of un-retouched proofs for his/her own personal use. At the discretion of Kelly Heasley Photography, LLC, selected fully retouched images chosen by Kelly Heasley Photography, LLC will be provided as a complimentary gift to the client. If the client requests that more images be retouched, Kelly Heasley Photography, LLC will do so for a fee of \$25 per image.

SERVICE AGREEMENT AND LIABILITY

In the extremely rare event that images are damaged or lost through camera or computer malfunction, the photographer liability will be limited to a retake of the session whenever possible or a refund of the cost if images cannot be retaken. If the session fee must be refunded, Kelly Heasley Photography, LLC will have no further obligation to the client. If additional hours are required or requested for the portrait session, the client will be billed at \$175 per hour plus tax.

The images will be licensed for reproduction and display to the client for personal use only.
